## Killoran takes onstage experience to courtrooms

Grant Killoran can see the similarities between performing onstage in a play and representing a client in front of a judge and jury.

Killoran, a shareholder at O’Neil, Cannon, Hollman, DeJong & Laing S.C., Milwaukee, and the chairman of the Litigation Practice Group, became involved in theater and debate while in college but chose against making acting a career. A professor suggested he consider law school.

“I realized that instead of performing to a large audience in a play in a theater,” Killoran said, “I could use some of what I had learned from my theater and debate instructors to talk to a different audience — the jury and the judge — in a courtroom.”

During his more than 25-year legal career, Killoran said, he has witnessed many changes,

and one of the biggest is that more cases settle before going to trial.

“With business cases, there is a more of a financial incentive for clients to settle their disputes prior to trial than there used to be because of the cost of the litigation process,” he said. “The power of courts to order parties to alternative dispute resolution before trial also impacts the trial process.

“There are significantly fewer civil trials than there used to be.”

One case that did not involve a trial, Killoran said, stands out in his career. The late Oakland Raiders owner, Al Davis, had sued the NFL and sought to serve subpoenas on every NFL team president. The subpoenas needed to be enforced in the counties where the NFL presidents lived.

A friend recommended Killoran to the Raiders’ California-based attorneys.

A Green Bay native and lifelong Packers fan, Killoran took the job and moved to enforce the Raiders’ subpoena on then-Packers President Bob Harlan. Despite the Packers’ objection to the validity of the subpoena, Killoran prevailed and the subpoena was enforced.

“So I represented the Raiders against the Packers in a Green Bay courtroom and won,” he said. “I was proud of my work and pleased for my client. I think I may have been the only attorney to get one of the Raiders’ subpoenas enforced.

“But I fear I’ll probably be kicked out of Packers’ heaven for it.”
